



# RS Feva Eastern Championships 2024

**Saturday 4<sup>th</sup> and Sunday 5<sup>th</sup> May 2023**

## NOTICE OF RACE

**ORGANISING AUTHORITY** This event will be organised by Greystones Sailing Club in conjunction with the Irish RS Feva Class Association.

The notation '[DP]' in a rule in this NoR means that the penalty for a breach of that rule may, at the discretion of the protest committee, be less than disqualification.

The notation '[NP]' in a rule in this NoR means that a boat may not protest another boat for breaking that rule.

### 1. RULES

- 1.1 The event will be governed by the rules as defined in The Racing Rules of Sailing.
- 1.2 The prescriptions of Irish Sailing
- 1.3 The RS Feva Class Rules will apply with the following amendment
  - 1.3.1. [NP] Class rule C5.1 (e) is changed to become a mandatory requirement. A 6m painter ready for immediate use, is required on all participating boats.

### 2. SAILING INSTRUCTIONS

- 2.1 Sailing Instructions shall be available online from the GSC website (<https://gsc.ie/feva2024>) from Wednesday 1<sup>st</sup> May.

### 3. COMMUNICATION

- 3.1 The online official notice board is located at the race office in GSC.
- 3.2 [DP] While racing, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

### 4. ELIGIBILITY AND ENTRY

- 4.1 The regatta is open to all boats of the RS Feva class. A regatta fleet using Dacron S mainsails will also be scored separately if there are sufficient numbers.
- 4.2 Helms shall be a member of the Irish or other National RS Class Association.
- 4.3 Eligible boats may enter by completing the entry form available online at <https://gsc.ie/feva2024>
- 4.4 Late entries, after Sunday 14<sup>th</sup> of April 2024, will only be accepted subject to the discretion of the Organising Authority

### 5. FEES

- 5.1 The entry fee shall be €75 to enter the event.
- 5.2 Feva Class Membership single event only - €7.50
- 5.3 RS Feva Class Annual Subscription - €15.00

## 6. ADVERTISING

6.1 [DP][NP] Boats may be required to display advertising chosen and supplied by the organizing authority.

## 7. SCHEDULE

7.1 Registration:

7.2 A briefing will take place on Saturday, 4<sup>th</sup> May at 10:30. Further details will be available in the Sailing Instructions.

7.3 Number of races

Date	Races
Saturday 4 <sup>th</sup> May	3
Sunday 5 <sup>th</sup> May	3

Up to 4 races may be run on a given day. To indicate this intention the Finish boat will display Flag Numeral 4 at the end of Race 3.

7.4 Times of racing

- The Warning Signal for the first race on Saturday 4<sup>th</sup> May will be: 11:55
- The Warning Signal for the first race on Sunday 5<sup>th</sup> May will be: 10:55.

7.5 No warning signal will be made after 15.00 on Sunday 5<sup>th</sup> May.

## 8. EQUIPMENT INSPECTION

8.1 A boat or equipment may be inspected at any time for compliance with the class rules, NoR and SIs.

## 9. VENUE

9.1 The regatta will be sailed in the waters of Greystones in the vicinity of Greystones Harbour.

## 10. THE COURSES

10.1 The courses will be Windward-Leeward and/or Trapezoid courses. The course details will be subject to confirmation in the Sailing Instructions.

## 11. PENALTIES

11.1 RRS 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

11.2 Appendix T and the Exoneration Penalty will apply to this regatta. Decisions from Arbitration can be referred to the protest committee but cannot be reopened or appealed.

## 12. SCORING

12.1 In accordance with RRS 90.3 the series shall be as provided in RRS Appendix A using the Low Point System.

12.2 A minimum of 2 races must be sailed to constitute a series.

12.3 When fewer than four races have been completed, a boat's series score will be the total of her race scores.

12.4 When four or more races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

## 13. BERTHING

13.1 [DP][NP] Boats shall be kept in their assigned places while in the boat park.

## 14. RISK STATEMENT AND DISCLAIMER OF LIABILITY

14.1 RRS 3 states: 'The responsibility for a boat's decision to participate in a race or to continue to race is hers alone.' By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. **Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.**

14.2 No responsibility shall be accepted by Greystones Sailing Club, their directors, members, servants or agents nor any of the sponsors, nor those officials or members connected with the Event, for any loss, damage or any other claim of whatever nature however arising or caused in connection with the participation in or intended participation in this event.

14.3 I agree to be bound by the Racing Rules of Sailing and all other rules that govern this race. In particular, I confirm that I have read the Notice of Race and accept its provisions and agree that:  
(a) my boat will conform to the requirements set out in the Notice of Race throughout the event;  
(b) personal information provided to the Organizing Authority will be used to facilitate the participation of myself, my boat and crew, in the event.

## **15. INSURANCE**

15.1 Each competing Owner(s) and competing crews shall ensure that they are adequately insured against loss, damage or injury to persons, boats or equipment at all times and however occurring and shall maintain Third Party Insurance Cover of not less than One Million Two Hundred and Fifty Thousand Euro (€1,250,000) for any accident. All owners/competitors who sign the Entry Form are deemed to have made a declaration that they hold such cover.

## **16. PRIZES**

16.1 Fleets may be split into e.g. Gold, Silver, Bronze and Regatta fleet dependant on entries and at the discretion of the Organising Authority, and First, Second and Third prizes may be awarded in each fleet.

16.2 Additional prizes may be awarded at the discretion of the Organising Authority.

## **17. DATA PROTECTION**

Any personal information provided to the organizing authority will be used to facilitate participation in the event. Competitors and support persons are bound by the Racing Rules of Sailing and the other rules that govern the event (the rules), the legal basis for processing that personal information is contract. For any person not bound by the rules, the legal basis for processing that personal information is legitimate interest. Personal information will be stored and used in accordance with the organizing authority's privacy policy. When required by the rules, personal information may be shared with Irish Sailing, a competitor's or support person's national authority and/or World Sailing. The results of the event and the outcome of any hearing or appeal may be published.
